

CONSENT TO PERSONAL DATA PROCESSING

An individual (the "Personal Data Subject"), in accordance with Federal Law No. 152-FZ dated 27 July 2006 "On Personal Data", acting freely, of their own will and in their own interest, confirming their legal capacity, and acting on a specific and informed basis, hereby gives this consent (the "Consent") to Акционерное общество «Центр Исследований и Разработок» (АО «ЦИР», Taxpayer Identification Number (ИНН) 7708419659), registered address: 101000, Moscow, intracity territory of the Krasnoselsky Municipal District, 13 Milyutinsky Lane, Building 1, Premises I, email: info@cir-innovations.ru (the "Operator") to process their personal data on the following terms:

1. This Consent is given for personal data processing both with and without the use of automated means.
2. Personal data processing includes, without limitation: collection; recording; systematization; accumulation; storage; clarification (updating or alteration); retrieval; use; transfer (provision or access) of personal data to third parties for the purposes specified in Clause 4; blocking; deletion; and destruction.
3. This Consent is specific, substantive, informed, conscious, and unambiguous.
4. This Consent is given for the processing of personal data that is not classified as special-category personal data or biometric personal data, to the extent necessary to achieve the purposes for which it is collected.

Consent is also given to transfer the specified personal data to a third party - ООО «Яндекс» (Yandex LLC) - to support operation of the personal data collection service:

5. The Personal Data Subject's Consent remains valid until the relevant purpose has been achieved, the consent to processing has been withdrawn, or the period established by the legislation of the Russian Federation has expired.
6. Consent may be withdrawn by the Personal Data Subject or their representative by sending АО «ЦИР» a written or electronic application to the Operator's postal address or email address specified at the beginning of this Consent.
7. If Consent is withdrawn, the Operator may continue processing personal data without it where the grounds specified in Clauses 2-11 of Part 1 of Article 6, Part 2 of Article 10, and Part 2 of Article 11 of Federal Law No. 152-FZ dated 27 July 2006 "On Personal Data" apply.
